

Official Rules

Please read these rules before entering the TTCU Giveaway (the "Contest") presented by TTCU Federal Credit Union (referred to herein as "TTCU", "We" or "Our"). You (the participant in the Contest "You" or "Your") agree that, by submitting an entry, You will be bound by these Official Rules and You acknowledge that You satisfy all contest eligibility requirements.

Eligibility. If You are an Oklahoma resident and are between the ages of 0-17 years of age at the time of entry, You are eligible to enter the Contest. No purchase is necessary for entry. You must be a member of TTCU to enter. Officers, employees and agents of TTCU, the Contest's other participating sponsors (if any) and their advertising agencies (if any), and members of the immediate family of any such persons are not eligible to participate and win. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.

How to Enter. You may enter the Contest in the following ways:

- By making two or more savings deposits at any TTCU branch, between April 1-30, 2024, that together total \$25 or more.

Limit one entry per person.

Prize. We will award 18 prizes, one prize per branch from the deposits received at that branch. Each winner will be drawn separately from the deposits received at each branch. Each prize will consist of a \$100 deposit into the winning member's S1 account. A 1099-INT or applicable tax form for the value of the promotional account credit will be issued to the account holder. Account holder is responsible for all fees and taxes associated with acceptance of the prize. Winner is responsible for complying with all applicable federal, state and local laws and regulations applicable to the prize.

Odds of Winning. Odds of winning depend on the number of eligible entries received.

Additional Terms. We may, to the maximum extent permitted by applicable law and in Our sole discretion, change these rules or cancel the Contest at any time; or modify, terminate, or suspend the Contest for any reason or other causes beyond our control that corrupt or impair the administration, security, fairness or proper play of the Contest or submission of entries. We are not responsible for: (a) lost, misdirected, late, incomplete, or unintelligible entries or for inaccurate entry information; (b) any printing or typographical errors in any materials associated with the Contest; (c) any error in the operation or transmission, theft, destruction, unauthorized access to, or failure to receive any entry information on account of technical problems or traffic congestion. We may, in our sole discretion, disqualify any individual found to be: (i) tampering with the entry process or the operation of the Contest; (ii) acting in violation of these rules; or (iii) acting in an unsportsmanlike or disruptive manner or with intent to annoy, abuse, threaten or harass any other person. If Your entry is incomplete your entry will be void. No greater than the number of prizes stated in these Official Rules will be awarded. If any technical errors occur in the selection of potential prize winner or if more prizes are claimed than the number of prizes being awarded as provided in these Official Rules, We may award the prize by random drawing from among all eligible claimants.

Miscellaneous. The Contest is governed by the laws of the State of Oklahoma. The Contest and all accompanying materials are copyrighted by TTCU and its affiliates with all rights reserved. If You win a prize, TTCU will not transfer or assign the Prize to anyone but You, nor will TTCU redeem the Prize for cash. We may substitute a prize with a prize of equal or greater value. The winner agrees (for

himself or herself and his or her heirs) that, by accepting the prize, TTCU will have no liability, and will be held harmless by the winner for any liability, loss, injury or damage to property or person, including death, and reasonable attorney's fees and court costs, due in whole or in part, directly or indirectly, by reason of the acceptance, possession, use or misuse of the prize or participation in the Contest, even if caused or contributed to by the negligence of any of the Released Parties. You agree that our decisions related to the Contest and all drawings are final. The winner agrees that, by participating in the Contest, We may use the winner's name, image or likeness in any manner and in any medium for our promotional purposes without additional compensation, except where prohibited by law. The winner and their guardian will be required to complete and sign a Publicity Release Form.
