# BOARD POSITIONS

The election of the TTCU Board and Supervisory Committee members occurs each year at the annual meeting. The Board is accepting applications for nomination from members who wish to run for office. Applications may be obtained from the Midtown office and require the endorsement of 100 TTCU members.

Applications must be submitted no later than January 15th, 2016 to be on the ballot at the annual meeting. Nominations will not be accepted from the floor. Candidates for office should be active TTCU members in good standing.

Nominations will be accepted for the 2016 annual meeting for a three year term for Supervisory Committee position number 2, and three year terms for Director positions numbers 6 and 7.

The 2016 annual meeting is scheduled to be held at the Tulsa Public Schools Education Service Center on March 24, 2016.
